To add to what I have already sent you I would like to share with you my thoughts on the future.

I support those Councils that have declared a Climate Emergency. I believe that we need to address the significant issues that face us in the 21st Century to do with climate change. I include here my policy statement.

- 1. Honour our commitment under the Paris Agreement to plan for and take action on climate change adaptation.
- 2. Plan and coordinate a cohesive approach for climate change adaptation, hazard management, resilience, and emergency management.
- 3. Support building owners in areas of increased risk of further earthquakes to meet the securing requirements under section 124 of the Building Act 2004.
- 4. Manage and protect water supply, stormwater and wastewater networks to protect the environment for all.
- 5. Adopt appropriate conservation and sustainable development strategies which recognise biodiversity as integral to our sustainable economy.
- 6. Reduce the environmental harm of waste and provide economic, social and cultural benefits for the Hurunui.
- 7. Establish a community-led Mayoral Advisory Group to ensure regular face-to-face communication with Hurunui residents.
- 8. Adopt bicultural approaches and bilingual understandings of hautūtanga/leadership to encourage cultural safety for all stakeholders.
- 9. Prevent homelessness, prohibit forced evictions, address discrimination, focus on our most vulnerable and ensure that all residents are housed adequately.
- 10. Promote recognised pathways to prosperity through targeted resource, social and economic development.
- 11. Address education capacity needs within with the Hurunui District with the provision of coeducational state secondary school in Amberley.
- 12. Strengthen the Hurunui District transport network to include a robust commuter rail network to Christchurch.
- 13. Review investment and expenditure categories to address governance spending for council support, support services, roading and drinking and waste water.
- 14. Develop a cohesive strategy to encourage public private partnerships committed to the development of improved infrastructure.
- 15. Ensure annual investment maintains the quality of the Districts assets and the service levels required.
- 16. Seek guidance and expert assurance and advice when setting and administering rates.
- 17. Provide recreation facilities including, an Aquatic Centre, suitable for the needs of children, families a and a growing elderly population.
- 18. Develop an integrated Tourism growth strategy.
- 19. Prioritise the reintroduction of specific visitor oriented infrastructure improvement projects cut in 2012/2013.
- 20. Provide a public transport commuter network to meet the needs of those without access to private transport.
- 21. Increase funding to expand and integrate the network of Hurunui Heartland Cycle Trails into neighbouring districts.
- 22. Provide for the development, maintenance, operation and upgrading of utilities while managing their adverse environmental effects.
- 23. To recognise that the location and siting of utilities has the potential to affect cultural values, including Ngāi Tahu values.
- 24. Manage reverse sensitivity effects on utilities giving priority to avoiding adverse effects on those utilities. Peggy

## Julia McLean

Thank you for the opportunity to state my position on the issue of Climate Change and local governments role with respect to leadership, mitigation and adaptation measures on behalf of community.

- 1. Are you going to declare a climate emergency? Yes
- 2. How do you think the Council should lead us to work together urgently to address the climate emergency? First of all, by declaring a climate change emergency the Hurunui District Council would be demonstrating that it is taking the climate challenge seriously and it will therefore give higher priority to council policy, decision making and action.

The local government sector recognises it has a significant role to play on behalf of community in mitigation (reducing greenhouse gas emissions) and adaptation (adapting to the effects of climate change) to build resiliance. It's imperative that we work together at a district, regional and national level to give full effect to our actions. The Hurunui District Council can show leadership on a number of levels. It can begin by embedding a Climate Change Strategy that will inform all other future council strategic plans. This strategy must place priority on climate change iniatives that empower collective action. Working together with Environment Canterbury, neighbouring local councils, iwi, the business industry, the scientific sector and the wider community is for me critical to building resilient communities.

Council must consider in its next Annual Plan and future Long Term Plan, funding for climate change iniatives — similar to Council planning to meet new drinking water standards and Earthquake Prone Building standards. I would propose a forum and a task force is established to enable council to work with community and stakeholders. Provision for a climate change champion would ideally be made at council.

Finally council could look at carrying out a Certified Emissions Management and Reduction (CEMARS) audit to understand how it can reduce the organisation's greenhouse gas emissions. Leading by example.

Your queries are not simple and straight forward to answer as a standing candidate who is not privy to the information not made public by council however I will do my best to answer your queries as best I can.

#### 1. Am I going to declare a climate emergency?

This is not a straightforward answer as declaring a climate emergency is all well and good but needs to be backed up by action & leadership to follow through with the declaration. In saying that, not declaring, and still powering ahead with the action & leadership is likely to give the same desired results, however the declaration gives a bit of a "grandstand" to push out from.

I personally believe the emphasis should be placed on the actions of "what are we going to do" more so than "declaring a climate emergency" which opens no new doors, nor give the council any greater powers to drive action.

I will support the Council if consensus is to sign, and will advocate if the majority of our constituents demands this of council, however I would prefer to put more energy into taking steps to solve the problems that our district contributes to climate change, and start planning for what we can do should things worsen (ie sea level rises).

Changes need to be made within council, but also within business and in people's homes. Solving this problem does not solely rely on governments and local bodies. We all need to make changes and we should have all started the day before yesterday!

#### 2. How do I think the council should lead us to work together urgently to address the climate emergency?

Without jumping to rash conclusions, we need to take a step back, and identify where we are making good progress and where we are failing. What/who are our biggest polluters (without doing the naming & shaming as that is going to achieve nothing) and what/who are giving back more to the environment than they are taking. Without all the clear hard facts it's not going to be easy to put the most appropriate plans in place to deal with these issues head on.

It is important to remember we don't have infinite resources so can't do everything all at once but does not mean we can't do everything! We will need to stage our major/expensive changes to ensure we can achieve our desired outcomes.

While I am aware of some of the big polluters globally, I'm not fully aware of all the polluters here within the Hurunui, where we can work for change. Without identifying these, we will not know where to start.

One example that jumps to mind is that we need to work with local business to reduce single use plastics, but on the flip side enable more recycling solutions for the plastics that still need to be recycled that we can't find suitable alternatives for. Our current recycling provider is not able to offer soft plastics recycling so we need to find someone who can!

In relation to your pledge requests, I am not able to answer as per your exact wording, however I am able to commit to the following

- 1. I will work to make the climate and ecological emergencies one of my councils top priorities as soon as possible. There are other very pressing issues which also need addressing within council, so without the inside knowledge, I cannot commit to making this "the" top priority at this time, but am happy to commit to making it one of the top priorities for Hurunui District Council.
- 2. I am happy to say yes to Pledge two.
- 3. I am happy to say yes to Pledge three, but without knowing the full extent of the problem within the Hurunui, and what steps are needed to make better these issues, along with the costs and other resources needed to make these changes I could not at this time commit to a year. By doing so could jeopardize the ability to achieve the desired outcomes we are striving to put in place.

While I appreciate these may not be the exact answers you want to hear, I believe my views are on the track of what you are hoping to achieve. I work to under promise and over deliver in all aspects of what I do. I also would like to emphasise to achieve our goals we will require full buy in from Council and most importantly our community.

I was interested to hear the Extinction Rebellion presentation run by Richard and Roy on 17 August. I found it a fair summary of the effects of climate change. Everyone should be aware of the issue as there is such an enormous amount of material available on the internet and in the media. It is hard to avoid.

Central and Local Government NZ have climate change on the agenda. LGNZ has a huge amount of educational material and runs webinars for councillors. Council is aware of climate change and has been factoring its effects into a number of decisions in recent times. There is obviously more work to do.

At this time, Council has not taken the issue of climate change to the Hurunui community for consultation. Consultation will identify what risks exist for the community and what the community wants Council to do. Until this has occurred we are unable to make a decision regarding the appropriate forward action. As a Councillor, I represent the whole rate-paying community. My personal views are not the issue here. As such I do not support the declaration of a climate emergency right now, nor am I in a position to commit to any pledges.

I hope you read my reply understanding that having studied and worked in the environmental space since 1990 (argghh – long time), I have more information on climate change than most. Therefore, I am making promises that if elected to Council I can keep rather than unequivocably saying yes to pledges and declarations to win votes. Why do I say that? Firstly because local government has a very limited role in climate change. It is primarily managed under the Climate Change Response Amendment Act 2008 and is a function of central government. As statutory agencies, local government can only act where they have powers, functions and duties under statute. Secondly, as only one potential Councillor around the table, I cannot commit the Council to do anything at this stage, any more than any other candidate can. So I am pledging what I will do if elected:

I pledge that I will raise the issue of climate change around the Council table;

I pledge that I will be raising other environmental issues too, including the need for strategic water supply planning for the future of our entire District;

I pledge that I will encourage Council to embark on a climate change action plan for our District – looking at what Council can do itself and how it can support others in our District, including providing robust, factual information on climate change;
